(DECLARATION FOR HARMFUL / TOXIN / BANNED COMPOUND FREE IN OPP FILMS)

This is to certify that all grades of Oriented Polypropylene (OPP) Films manufactured and supplied by Jindal Poly Films Limited are free from the harmful / toxin / banned compounds listed below.

- 1 Heavy Metals and their derivatives – Lead (Pb), Cadmium (Cd), Chromium (Cr), Mercury (Hg)
- 2 Phthalate Plasticisers – Di(2-Ethylhexyl) Phthalate (DEHP), Dibutyl Phthalate (DBP), Dibutyl Adipate (DBA), Dioctyl Phthalate (DOP), Dioctyl Adipate (DOA) etc.
- 3 Butylated Hydroxy Toluene (BHT), Butylated Hydroxy Phenolics (BHP)
- 4 Tin Base Organometallic Compounds – Dibutyl Tin (DBT), Tributyl Tin (TBT), Triphenyl Tin (TPT) etc.
- 5 Halogen (Chlorine, Fluorine, Bromine and Iodine) Based Compounds and their Derivatives
- 6 Phosphorus Base Organic Compounds – Trisnonylphenylphosphite (TNPP), Tris(di-nonylphenyl) phosphites (TDNPP) etc.
- 7 Bromine Base Organic Compound – Polybrominated Biphenyls (PBB), Polybrominated Diphenyl Ethers (PBDE), Polybrominated Biphenyl Oxides (PBBO) etc
- 8 Substance Contains Bisphenol A (BPA) or Material produced using Bisphenol A like Epoxidic Derivatives (BADGE, BFDGE, ENOGE etc.), Bisphenol Nonylphenol Ethoxylates etc.
- 9 Substance derived from animal, vegetal, human sources
- 10 Isopropylthioxanton (ITX)
- 11 Substances responsible for depleting Ozone Layer – CFC, HCFC, Methylbromide, Trichloroethane, Carbon Tetrachloride, Chlorine containing organic solvents etc.
- 12 Other Compounds – Dioxines, Chlorinated Paraffines, Polychlorinated Biphenol (PCB) and Polychlorinated Triphenol (PCT) category, Polychlorinated Naphthalene category, Azo compounds, Formaldehyde, Asbestos, Plasticisers / Antioxidants / Softener compounds, Allergen compounds – Natural Latex etc, Genetically Modified Substances, Acrylamide, Melamine and Melamine Based Compounds, Cyanuric Acid and Compounds, 4-Methylbenzophenone (4-MeBP), Benzophenone, Hydroxybenzophenone.
